Evaluation of educational programs was carried out in June-July. Vocational education of hairdressing and nail dressing teachers evaluated the mentioned programs. The result of the evaluation revealed the tics that related to the diversity of the topic as well as making changes in the curriculum. Parts of the said design have been provided to the AIP Vocational Skills Agency, which is revising the educational standard.

In cooperation with the State Agency for Promotion of Employment of IDPs from the occupied territories of Georgia, under the state control of the Ministry of Labour, Health and Social Protection, three groups were recruited. The academy company cooperated with the AIP Professional Skills Agency and obtained the right to implement professional training programs of "hair cutting", "hair coloring" and "nail care grooming" for three groups. Also, in December 2023, the Academy of IDPs from the occupied territories of Georgia, State Agency for Employment Promotion under the state control of the Ministry of Labour, Health and Social Protection, announced training on the professional training program of "Hair Dyeing Speciality". This year, the Academy received 7 groups.
